SCHOLARSHIP APPLICATION REQUIREMENTS

Note: This document is to preview our scholarship application **only** – the [Summer Scholarship Application](#) is a Microsoft Form located on our [website](#)'s sidebar.

- Teens ages 14 to 19 are eligible to apply to Teen Academy programs.
- Pre-teens ages 11-13 are eligible to apply to Pre-teen Academy programs.
- Students will need access to a smartphone, DSLR or mirrorless camera, or a digital point and shoot camera to complete assignments as per course requirements. If they do not have their own device, there are a limited number of DSLR and SLR cameras that can be signed out from ICP.
- A picture is required and will be used to create your ICP ID. Please send an image similar to a passport photo of your head and shoulders against a solid, light-colored wall or other plain background.
- Scholarships are determined based on a committed interest in the program as well as financial need. To determine the financial need, applicants will be prompted to fill out a financial information section of the application with their parent/guardian.
